# 10-YEAR WARRANTY FOR CORRUGATED SINGLE SKIN LIGHTPIU' SHEETS RESISTANCE TO THE ATMOSPHERIC EVENTS AND HAIL

#### A) WARRANTY DECLARATION

The warranty covers all POLYPIU' products in corrugated UV protected single skin polycarbonate with the following characteristics:

- after 10 years, the product's light transmission value will be no more than 10 percentage points below the initial value, measured according to ASTM D-1003-77 standard.
- 2) after 10 years, the degree of yellowing, determined according to ASTM 1925-77 test method, will be no more than 10 delta units below the initial value.
- 3) after 3 years, the product will not break due to hail, based on the results of a hail impact simulation test using 20mm diametre artificial balls at an impact speed of 21 m/s.
- after 3 years, the outer UV protection will not show damages due to normal atmospheric conditions.

#### B) WARRANTY EXCLUSIONS

The warranty does not apply in the event of damage by accidental impacts and vandalism, and excludes: transportation, removal and new installation or other uses. The warranty is not valid if the defect can be attributed to violent knocks during transportation and/or handling, or to "incorrect" storage, machining, installation and conservation; "incorrect" situations are when the instructions contained in the POLYPIU' documentations and technical handbooks are not followed and particularly with regards to the radii of cold-curving carried out on site.

### C) WARRANTY LIMITS

The present warranty was issued on 1st January 2017 and replaces any other written and spoken warranty, express or implicit, including warranties of merchantability.

# D) WARRANTY VALIDITY CONDITIONS

The UV protected POLYPIU' products:

- 1) must be free of scratches and/or abrasions
- must not be damaged by connection, fixing and/or insulating elements
- must not be exposed to the action of chemical products or corrosive materials

- must be installed with the UV protected side facing outwards, exposed to the weather
- 5) must be supplied and installed in Europe
- are also guaranteed in the event of corrugated single skin sheets manufactured by POLYPIU'

NOTE: Upon request from POLYPIU', the claimant must allow the material to be inspected on site and/or the claimed product must be returned to POLYPIU' for assessment. POLYPIU' reserves the right to assess the cause of the defect independently.

- 7) the present warranty is not valid for thermoformed sheets or for sheets whose original profile was altered
- 8) so as the warranty be valid, sheets must be installed according to the manufacturer's recommendations, including:
- a) cutting, drilling and handling as indicated the POLYPIU' technical handbooks
- b) specific details for curved installations
- any other information contained in labels and publications with regards to the sheet
- d) keeping a suitable spacing of the purlins
- e) complete keeping of fixing recommendations, by avoiding screw overtightening
- f) steady storage of the sheets under an opaque covering.

## E) PLACE OF JURISDICTION

This warranty is governed by national laws – the place of jurisdiction for any controversy will be the Milan law court.

#### F) WARRANTY ENFORCEABILITY

- 1) Every warranty application request must be sent to POLYPIU' within 30 days after the defect has occurred, along with a copy of the warranty and of the invoice so as to obtain an extension to 10 years (see table below).
- The damage claimed and the presumed causes must be clearly described and documented in order to proceed with concession of the warranty.

In the event of justified claim, POLYPIU' will replace the material free of charge in accordance with the following table, without recognition of blame:

Period from the date of purchase	Replacement percentage of claimed material
Up to 5 years 100%	8th year 45%
6th year 75%	9th year 30%
7th year 60%	10th year 15%

In the event that replacement within a reasonable period of time is not possible, POLYPIU' reserves the right to reimburse the product's original price, based on the above table, without recognition of blame.
